HOUSEBOUND DIC Housebound add \$143.12
You must meet one of the following conditions to receive the Housebound benefit:
 Your disability confines you to your home, OR
 You have one condition rated 100% disabling AND another condition rated 60% or more disabling

AID & ATTENDANCE DIC A&A add \$305.52
You must meet one of the following conditions to receive the Aid & Attendance benefit:
 You need constant help with your daily needs such as bathing, dressing or eating, OR
 You are blind, OR
 You are a patient in a nursing home
